ORDER :

In the Government Order first read above, the number of special categories under special reservation for MBBS/BDS course has been reduced to 4 categories, viz., Physically Handicapped, Eminent Sportspersons, Children of Freedom Fighter, Children of Ex-servicemen and the number of seats reserved for Children of Ex-Servicemen had been restricted as 2 for MBBS and 1 for BDS course.

2. In the Government Order second read above, the Government have enhanced the MBBS seats earmarked to the Children of the Ex-servicemen under special reservation from 2 seats to 5 seats from the academic year 2015-2016.

3. Thiru M. Ramasamy has filed a W.P. No.37163 of 2015 before the Hon'ble High Court of Madras with a prayer to comply the guidelines issued by the Government of India for enhancing the Ex-servicemen quota. In its order third read above, the Hon'ble High Court of Madras has ordered as follows :-

We may have full sympathy with the petitioner, but legally, not much is possible as this issue has already been examined by us in W.P.No.24502 of 2014 (M.Arjunan -Vs- State of Tamil Nadu, rep. by its Secretary to Government, Health and Family Welfare Department, Fort St. George, Chennai-9 and others), decided on 10.09.2014 and the contempt petition flowing there from, being contempt petition No.661 of 2015. We can only quote paragraphs 2 and 3 of our order in the contempt petition dated 09.07.2015, which reads as under :-

"2. In our view the fallacy is in comparing the population ratio for the reason that it does not seek to recognize the role played by the Armed Services people at the borders of the country. It is not as if the remaining population is willing to go to the borders".

3. The State Government ought to have derived inspiration from the neighbouring States including Karnataka, which is stated to have given 10% of the ratio, as against 0.22% in Tamil Nadu. This itself shows the odious comparison. In most States, there is an increased figure and that is the reason why we thought that at least 2% reservation as against the total population should have been made, but that is not to be. We are in contempt proceedings and we can say no more than to express our concern in the manner in which the State Government has decided to treat the wards of the Ex-Servicemen. At least for the next academic year, we expect that the State Government will take a more positive stand, considering how the neighbouring States are dealing with the percentage of reservation for the wards of the Ex-Servicemen".

4. In his letter fourth read above the Additional Director of Medical Education / Secretary, Selection Committee has stated among others that the total number of applications received were 32,184 for admission to MBBS / BDS course for 2015-2016 session and that 632 candidates have applied under Ex-Servicemen quota i.e. approximately 2% applied and therefore, has requested the Government to issue appropriate orders.

5. In his letter fifth read above, the Joint Secretary to Government of India, Ministry of Defence has issued a list of priorities for reservations or preferences to the wards of Armed Forces personnel by States / UTs/ Central/ State Universities / Autonomous Institutions for admission in Medical / Professional /Non-professional courses and requested the competent authority to approve the same and implement it early.

6. The Government after detailed examination have decided to enhance the number of seats reserved under Ex-Servicemen quota from 6 to 11 seats (i.e. 10 seats for MBBS and 1 seat for BDS) in Government Medical and Dental Colleges from the academic year 2018 – 2019 on the priorities of reservation, listed out by the Government of India, Ministry of Defence. The Government accordingly do and hereby direct that the number of seats reserved under Ex-Servicemen quota from 6 to 11 seats (i.e. 10 seats for MBBS and 1 seat for BDS) in Government Medical and Dental Colleges from the academic year 2018 – 2019 be enhanced, on the priorities of reservation, listed out by the Government of India, Ministry of Defence, on the following manner with a provision that the number of eligible candidates in Ex-servicemen category;

- Priority - I Widows / Wards of Defence personnel killed in action
- Priority – II Wards of disabled in action and boarded out from service.

- Priority - III Widows / Wards of Defence personnel who died while in service with death attributable to military service.
- Priority - IV Wards of disabled in service and boarded out with disability attributable to military service.
- Priority - V Wards of Ex-Servicemen who are in receipt of Gallantry Awards.

 - ii) Ashok Chakra
 - iii) Sarvottam Yudh Seva Medal
 - iv) Maha Vir Chakra
 - v) Kirti Chakra

ORDER :

Thiru.V.Periyadurai had filed a Writ Petition (MD) No.5209 of 2017 before the Hon'ble Madurai Bench of Madras High Court, Madurai with prayer to increase the Sports Quota Seats in Tamil Nadu Medical and Dental Colleges from 3 to 20. In its order's first read above, the Hon'ble High Court of Madras has ordered as follows:-

"Though the number of seats in Medical and Dental Colleges has been hiked periodically, the number of seats reserved for sports quota has remained constant. It is hardly necessary to emphasize the importance of sports. It is the duty of the State Government to give sufficient encouragement in this competitive world. Unless, there is some reservation for sports quota, students will not be encouraged to take up sports seriously. Therefore, we direct the respondents to consider the representation dated 06.06.2016."

2. In his letter second read above, the Additional Director of Medical Education has requested to enhance the Sports quota seats, since during the year 1994-1995, only eight Medical Colleges were functioning with an annual intake of 950 numbers of seats. Now, 22 Government Medical Colleges and 1 Dental College are functioning in Tamil Nadu with an annual intake of 2900 numbers of seats under MBBS and 100 numbers of seats under BDS courses. Among the total number of seats, 15% of seats (i.e. 455 Nos. of seats under MBBS + 15 No. of Seats under BDS) are surrendered to All India quota. The remaining 85% of seats (i.e. 2445 Nos. of seats under MBBS + 85 Nos. of seats under BDS) are allotted to State quota. On comparing the above data, it is found that the total numbers of seats as well as the number of colleges have increased to a greater extent when compared to the previous years. Hence, it is logical to increase the number of MBBS seats earmarked to Sports quota under Special Category. Hence he has requested the Government to increase the number of seats reserved under Sports quota for admission to MBBS and BDS courses from 3 to 8 (i.e. 7 numbers of seats under MBBS and 1 number of seats under BDS) in Government Medical and Dental Colleges.

3. The Government, after detailed examination have decided to accept the proposal of the Additional Director of Medical Education / Secretary, Selection Committee, Office of the Director of Medical Education and to enhance the number of seats reserved under Sports quota in admission to MBBS and BDS courses from 3 to 8 (i.e. 7 seats on MBBS and 1 seat on BDS) in Government Medical and Dental Colleges from the academic year 2018 - 2019. Accordingly, the Government do and hereby direct that the number of seats reserved under Sports quota for admission to MBBS and BDS courses be enhanced from 3 to 8 (i.e. 7 seats on MBBS and 1 seat on BDS) in Government Medical and Dental Colleges from the academic year 2018 - 2019.

4. The Additional Director of Medical Education / Secretary, Selection Committee is directed to take necessary action, accordingly.

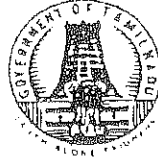

Priority-VI Wards of Ex-servicemen

2. The Secretary, Public (Ex-Servicemen) Department, has stated that Government of India, Ministry of Defence, Department of Ex-servicemen Welfare, New Delhi has revised the Inter-se priorities for reservation / preference to the wards of Armed Forces Personnel by State / Union Territories for admission to Medical / Professional / Non- Profession Courses. He has therefore, requested to take necessary action to amend the G.O (D) No.977, Health and Family Welfare (MCA-1) Department, dated 01.06.2018 by excluding the Yudh Seva Medal series of awards (Sarvottam Yudh Seva Medal, Uttam Yudh Seva Medal and Yudh Seva Medal).

3. The Government have examined the request made by the Secretary, Public (Ex-Servicemen) Department and decided to accept the same. Accordingly, the Government do and hereby issue the following amendment to the G.O (D) No.977, Health and Family Welfare (MCA-1) Department, dated 01.06.2018:
