

**PROCEEDINGS OF THE COMMITTEE ON FIXATION OF FEE IN RESPECT OF
SELF-FINANCING PROFESSIONAL COLLEGES, DATED 15.10.2022**

2) Fee Proposal submitted by Srinivasan Medical College and Hospital
under Dhanalakshmi Srinivasan University and Sri Venkateshwaraa
Medical College and Hospital and Research Institute.

1. With reference to G.O. first cited the committee was constituted for fixation of fee in respect of Self-Financing Professional Colleges and now it is functioning under the Chairmanship of Hon'ble Mr. Justice K. Venkataraman.
2. The Medical Colleges listed herein have submitted the proposals for Fixation of Fee for Under Graduate MBBS Course for the academic year 2022-2023.

Sl. No.	Name of the Colleges
1.	Srinivasan Medical College and Hospital under Dhanalakshmi Srinivasan University Samayapuram, Tiruchirappalli.
2.	Sri Venkateshwaraa Medical College and Hospital and Research Institute Redhills.

3. (a) The above referred Srivasan Medical College and Hospital under Dhanalakshmi Srinivasan University has got letter of permission, hereinafter called LOP approved from National Medical Commission, New Delhi on 1.11.2021 under Dhanalakshmi Srinivasan University (Private University) at Samayapuram, Tiruchirappalli from the academic year 2022-2023. The college also got approval from the National Medical Council.

3.(b) Sri Venkateshwaraa Medical College and Hospital and Research Institute, a constituent college of Sri Venkateshwaraa University was established under the Tamil Nadu Private University Act, 2019. Permission to establish the said college was issued by National Medical Commission to start MBBS Course with 150 students intake for the academic year 2022-2023.

4. The Hon'ble Supreme Court of India by an order dated 19.9.2022 in SLP Nos. 13213-13214 held:

"The Petitioner Srivasan Medical College and Hospital is a constituent college of the Dhanalakshmi Srinivasan University established under the Tamil Nadu Private University Act, 2019. It has been granted Letter of Permission by the National medical Commission. This institution shall be allotted 150 students in the MBBS Course from the present Academic Year 2022-23 onwards by the designated authority.

2. The Petitioner, a minority institution will share 75 seats (50% of the total seats) as government quota., in the MBBS Course, to the State of Tamil Nadu. For all the MBBS seats in the Petitioner institution, the Petitioner will approach the Fee Committee appointed by the State in terms of the Judgement of this Hon'ble court in Islamic Education Society's case, immediately with all necessary documents to enable

fixation of fee by the Committee from the Academic Year 2022-23 onwards”.

5. In the Judgment dated 19.5.2022 reported in 2022 LiveLaw (SC) page 501, the Hon'ble Supreme Court of India has held in para 14 (e) as follows:

“14(e) While fixing fee, the Fee Fixation Committees of the States should take into account all the components of fee, leaving no scope for managements to charge any additional amounts apart from what has been prescribed by the fee fixation committee from time to time. In the event that the management intends to charge additional amounts over and above the price band fixed by the Fee Fixation Committee, or for any component not included in the structure fixed by the Fee Fixation Committee, the same can only be done with the concurrence of the Fee Fixation Committee”.

6. Considering the above referred Judgments this Committee has decided to fix the fees for the above said colleges.
7. The Committee verified the Expenditure Statement based on the 20 Major heads namely Salaries and allowances including PF (Teaching, Non-Teaching and Administration), Welfare Expenses, Electricity Charges, Telephone, Postage & Internet, Equipment Purchase, Books & Periodicals, Printing & Stationary, Consumable, Research and Development, University affiliation fees and Inspection Charges, Sports, Games, Meetings and Functions, Awards, Merit Scholarship, Travelling and Conveyance, Repairs and Maintenance, Depreciation, Advertisement and Miscellaneous Expenditure.
8. The expenditure under various heads claimed by the Medical Colleges was considered and it was found that the colleges have claimed estimated expenditure under various heads of expenditure. The Auditor who is the member of the Committee was requested to scrutinise the

records and his opinion was also taken into consideration while fixing the fees.

9. The Medical Colleges for which this order is passed is a minority institution and hence seat sharing for admission of students will be 50% for Government Quota and 50% for Management Quota.

10. There are social needs which are required to be taken in to account in determining as to how much portion of the totality of expenditure can be passed on to the student.

11. The Committee discussed in detail and considered the following,

- i. Based on MCI Standards and Norms.
- ii. The expenditure details submitted by the colleges in its proposals under various heads referred in para 7 of our Order.
- iii. The opinion of the Auditor, the Member of the Committee.
- iv. Request submitted on behalf of the Colleges.
- v. Seat sharing for admission of the students in the Colleges.

12. Considering the entire matter this committee pass the following order.

ORDER

A. The Committee fixed the following fees all including Tuition fee, Admission fee, Special fee, Laboratory / Computer / Internet fee, Library fee, Sports fee, Maintenance and Amenities fee, Extracurricular activities fee, and other recurring expenditure.

B. The maximum fee structure prescribed will take effect for the students admitted for the academic year 2022-2023 and it will be for 3 years. If for any reason, the colleges need modification of the fees from next

academic year 2023-2024, the colleges are at liberty to apply for Revision of fees setting out the reasons thereof and the Committee will consider the same if it is of the view such request is Reasonable.

- C. In addition to the above fees, the institution is permitted to collect an amount of Rs.40,000/- per student as development fee.
- D. The management is directed to cover all the Students under Students Group Insurance Scheme.
- E. The above fee does not include Hostel, Transport, and Mess charges which is optional for the students.
- F. The Committee directs that the institutions shall not collect or levy any other recurring or nonrecurring fee including capitation fee. The Medical Colleges shall follow the direction laid down by the Hon'ble Supreme Court of India, referred to in para 5 of this order.
- G. Any deviation from this order of the committee will entail serious penal consequences like withdrawal of approval by MCI and disaffiliation by the concerned University as well as imposition of fine.
