  - (b) Physics, Chemistry, Biology with any other subject.

**Note:** Candidates who have passed in other board of examination (i.e., other than the Tamil Nadu State Board, CBSE and ISCE) with same subjects as mentioned above in clause 4 should produce the Eligibility Certificate from The Tamil Nadu Dr. MGR Medical University before attending the Counselling.

ii. Candidates who have passed the qualifying examinations from *National Institute of Open Schooling\** or *State Open Schools\** or *as private candidates\** from recognized State Boards; or with Biology/Biotechnology as an additional subject shall be allowed but subject to the outcome of Special Leave Petitions / Appeals filed by the Medical Council of India.

Note: \*"The proviso in italics has been a subject matter of challenge before the Hon'ble High Court of Delhi, Hon'ble High Court of Allahabad, Lucknow Bench and Hon'ble High Court of Madhya Pradesh at Jabalpur. The provisions of the regulations disqualifying recognized Open School Board candidates and the candidates who have studied Biology/Biotechnology as an Additional Subject has been struck down"

- 5. The following categories of candidates are NOT ELIGIBLE to apply for B.N.Y.S. Course.
- a. Candidates who have passed Higher Secondary Certificate Examination in Vocational Stream, Pre-University Course in Tamil Nadu, and who used scribe, who did not study English as a subject in Higher Secondary Certificate Examination.
- b. Candidates presently pursuing the B.N.Y.S. Course.
- c. Candidate native of other states and studied in other states.
- d. The selection and admission of candidates other than those mentioned in Clause 4 (i) will be provisional subject to recognition of the qualifying examination by The Tamil Nadu Dr. M.G.R. Medical University under which the candidate gets admitted. In case, the recognition is not accorded for the admission of the candidate on any grounds, the provisional admission will not entitle the candidate for the continuance of the course and the admission will be stands cancelled.

- i. In case of candidates who have furnished the mark-sheets of the qualifying examination, only in GRADES, the **minimum marks of the grades alone** will be taken into consideration while determining the marks in the Science subjects of Physics, Chemistry and Biology or Botany and Zoology.
- ii. Candidates who have submitted marks sheets with GRADES and without mentioning the range of marks for each grade should obtain the marks equivalent certificates from the examining authority and attach a certified copy along with their mark sheet as an enclosure with the application.

#### 8. **DURATION OF THE BNYS COURSE:**

The duration of BNYS course is five and half years including one year of Compulsory Rotatory Residential Internship.

#### 9. **DETERMINATIONS OF RANK OF THE CANDIDATES:**

a. Ranking will be made by merit on the basis of marks obtained by the eligible candidates in the prescribed science subjects in the qualifying examinations reduced to the base of 200 marks. The marks obtained through different Boards of Examination will be taken into account after normalization of marks.

The percentage and weighted total should be accurate to two decimals.

#### b. Normalization of Marks:

i) The marks obtained by the students in the relevant subjects in the qualifying examination conducted by various Boards or Authority will be equated with the marks obtained by the students in the same subjects in the qualifying examination conducted by the State Board of Tamil Nadu by adopting the method of normalization.

**Explanation:** - Under the method of normalization, the highest mark obtained by the students of various Boards in each subject will be equated to the highest mark obtained by the students of State Board in that subject and the relative marks obtained by other students in that subject will be determined accordingly.

**Illustration**: - If the highest mark secured by the student of State Board in Physics is 100, and the highest mark secured by the student of any other Board in the same subject is 90, both the highest mark will be considered to be equal to 100. If the student of the Other Board secures 60 marks in Physics when the highest mark in Physics in the same board is 90, the 60 marks will be considered to be equal to 66.66 marks as arrived at below: -

$$100 \times 60/90 = 66.66\%$$

ii) After normalization of marks in the relevant subjects in the qualifying examination conducted by different Boards, the qualified students of different Boards will be merged into a common merit list.

#### c. Determination of Rank of Candidates Obtaining Equal Marks (Inter Se Merit):

In cases, where two or more candidates obtain equal aggregated marks for 200, the rank of such candidates shall be determined on the basis of the following order:

- (i) Percentage in Biology or Botany and Zoology taken together in qualifying examination.
- (ii) Percentage in Chemistry in qualifying examination.
- (iii) Percentage in fourth optional subject in qualifying examination.
- (iv) Date of Birth- Weightage given to seniority in age
- (v) Computerized Random number assigned. Higher value of Random Number will be taken into Consideration.

The fees so exempted shall be claimed by the respective institutions under the scholarship program (As per G.O.Ms.No.06 Adi Dravidar and Tribal Welfare Department dated 09-01-2012). Candidates should furnish supportive documents like Valid Income Certificate and Community Certificate (Self- attested Photostat copies in triplicate) obtained from the competent authority along with the application.
- The candidates who are allotted seats in Self-Financing Yoga and Naturopathy Medical College shall remit a Non-refundable sum of Rs.10000/- (Rupees Ten Thousand only) by Cash / Demand Draft.
