The Chairman of the committee ascertained that the failure rate of sterilization is within the acceptable limit and the failure cases should be followed at the initial stage and sterilization to be done following with D&C or MTP, as the case may be.

The District Collector instructed the Deputy Director of Family Welfare to study the reason for failure and take necessary steps to keep the failures in acceptable limit.

Then the Committee accepted the reasons of the above Twelve failure of sterilization and recommended for the Family planning Indemnity scheme claim as per the Government of India Norms.

The Deputy Director of Medical Rural Health Services & Family Welfare, Tirunelveli was informed to adopt and adhere to the instructions and guidelines issued by the Director of Family Welfare Chennai for the Family Planning indemnity scheme claim for the above eligible cases.
